**IRA COHEN** is the founder and principal of IRA COHEN, P.A., a Weston, Florida specialty law firm. He is a member of both the Florida and New York Bars and has been practicing intellectual property law (copyrights, patents, and trademarks) for well over four decades. Ira graduated from

Queens College in 1977. He earned his first law degree (JD) in 1981 and his second law degree (LLM) in 1985. He is rated AV Preeminent by Martindale Hubbell<sup>®</sup>.

Ira is a member of the Florida and New York Bars, the various district courts in Florida and New York; the First, Second, Sixth, Seventh, Ninth, Eleventh, and Federal Circuit Courts of Appeal; and is a member of the Bar of the United States Supreme Court.
